Line 1 and 3 - From the information provided, it is unclear on who the applicant is. Signature/Certification - If the applicant is a sole proprietor, please select the “I am the applicant” checkbox. The applicant should then date, print and sign his/her name on the appropriate lines. However, if the applicant is a partnership, please select the “I am the _____” checkbox. The general partner should be stated on the “Office Held Line”. Please have the authorized individual date, print and sign his/her name on the appropriate lines.

Specimen – The specimen is not acceptable. A specimen is an actual example of how you are using the mark in commerce on or in connection with the identified goods. This is not the same as the drawing of the mark on your items, which merely represents what you are claiming as the mark. A specimen for a mark used on goods shows the mark on the actual goods or packaging for the goods. You may submit a copy of (1) the tag or label for the goods, (2) the container/packaging for the goods, (3) the display associated with the goods, or (4) a photograph of the goods that shows use of the mark on the goods. Please also submit a sample of the mark.
