The above-mentioned document is returned for the following reason(s):

I am not certain what your intent it. I reached out on April 16, 2024, for a response, but did not receive a reply by the morning of April 19, 2024.

A Hawaii Certificate of Limited Partnership was submitted first, followed by a foreign limited partnership name reservation. Foreign means that the entity started in another state or another country. A name reservation only holds a name for 120 days IF you are not ready to register/submit the limited partnership documentation. If you have already submitted the starting documentation, there is no reason to file/proceed with the name reservation filing.

As there was no issue with the first filing, this document was taken.

If you wish to still proceed with a name reservation filing, please see the following.

**Entity Type** – If the entity type has changed, please update this as needed.

Line 2 – The address is not acceptable. Please provide the complete address (street name, city, state, zip code). Generally, you do not need to state your name in the address section.

- 7. After resubmitting, you can view the original submission and the resubmission(s) by clicking the 'View Submitted' button in 'My Filings'
- 8. If you make an error in your resubmission, please contact the Business Registrant Assistant who has reviewed the document and is listed in the email from BREG.

#### The deadline to resubmit is May 19, 2024.

The filing fee will be applied to the corrected document if it is resubmitted within the prescribed time. Otherwise, the fee is NOT REFUNDABLE.
